### About HRSD and the Culture for Development Programme

The Human Rights and Social Development Division (HRSD) of the Pacific Community (SPC) has a vision for just, equitable and resilient Pacific societies and it aims to achieve this by advancing human rights, equality, and social inclusion for all Pacific people, grounded in cultural values and principles. HRSD's Culture for Development programme aims to ensure that cultural knowledge is protected and dynamic in development policy and programming and that skills and opportunities grow for income generation and sustainable livelihoods among women, young people, artists, and cultural producers.

# ACP-EU Enhancing capacity for the sustainability of Cultural & Creative Industries in the Pacific

This is a 3-year project that began in 2021. It is worth 2.1 million Euros in grants offered in three categories. The Pacific community (SPC) is lead implementing agency in partnership with QUT. The grant scheme is open to ACP Pacific countries: Cook Islands, Micronesia, Fiji, Kiribati, Marshall Islands, Nauru, Niue, Palau, Papua New Guinea, Samoa, Solomon Islands, Tonga, Tuvalu, Vanuatu and Timor Leste.

This grant scheme is made possible with the financial contribution of the European Union and support of the secretariat of the Organization of African, Caribbean, and Pacific states.

### About the grant scheme

The objectives of the project are to support National / regional development related to the CCIs, amplify Knowledge, research and learning on CCIs for capacity, programme, and policy development, enhance the skills of Artists and cultural producers and provide financial support to achieve intended grant outcomes. Projects supported under this grant scheme must align to one of the four thematic which include: The creation of high-quality goods and services, activities that increase access to national, regional and international markets, Visual literacy education and Access to sustainable financing. ### **Eligibility and selection**

Artists, cultural producers, NGOs/CSOs, institutions or organizations from the ACP Pacific countries may submit an expression of interest. Please refer to the <u>Guidelines Document</u> provided to review the detailed eligibility criteria for the different categories of grant funding.
