The Pacific Women Lead programme at the Pacific Community (SPC) is offering grants for gender equality initiatives. Grants aim to support partners to implement Pacific regional gender equality commitments and contribute to Pacific Women Lead outcomes.

#### **About Pacific Women Lead**

Pacific Women Lead (PWL), one of the largest global commitments to gender equality, aims to promote women's leadership, realise women's rights, and increase the effectiveness of regional gender equality efforts. The PWL at SPC programme has more than AUD 55 million dedicated to its work under the Australian Government's AUD 170 million Pacific Women Lead portfolio. ## How to apply for a grant

To apply for a grant, complete and submit the online Expression of Interest (EOI) form available through the SPC website: <a href="https://hrsd.spc.int/node/1022">https://hrsd.spc.int/node/1022</a>. The call for grant EOIs is **open for five** weeks, from Monday 31 October to Tuesday 6 December, 2022. ### **Grant funding available**

The PWL programme at SPC is offering multi-year grants (up to 2 ½ years) of AUD 100,000 to AUD 500,000 in financial support to civil society organisations including women's groups; social enterprises; academic or research institutions; Statutory or State institutions; and national and regional coalitions for their gender equality initiatives. SPC is also offering direct funding and technical support to Pacific Island Government members. This support will be determined in collaboration with member Governments and is **not included in this 31 October grants call**.
