Part 1: INTRODUCTION

1.1 About the Pacific Community (SPC)

The Pacific Community (SPC) is the principal scientific and technical organisation of the Pacific region, established by treaty in 1947 with the signing of the Agreement Establishing the South Pacific Commission (the Canberra Agreement).

SPC has our headquarters in Noumea, New Caledonia and has regional offices in Fiji, the Federated States of Micronesia and Vanuatu, as well as an office in France. SPC works across the Pacific and has staff in nearly all of our Pacific Island Country and Territory members.

SPC works for the well-being of Pacific people through the effective and innovative application of science and knowledge and is guided by a deep understanding of Pacific Island contexts and cultures. Our unique organisation covers more than 20 sectors and is renowned for knowledge and innovation in such areas as fisheries science, public health surveillance, geoscience and conservation of plant genetic resources for food security.

1.2 SPC's procurement activities

SPC's procurement activities are guided by the principles of high ethical standards, value for money, open competition and social and environmental responsibility and are carried out under our Procurement Policy.

SPC's *Procurement Policy* provides the framework for ensuring that SPC obtains the best value for its purchases, in terms of both cost and quality; demonstrates financial probity and accountability to its members and development partners; manages and prevents the potential for conflicts of interest; reduces its environmental impact and manages any other risks.

At SPC, all procurement follows the same main steps: planning; statement of needs; requisition; solicitation; evaluation; award; receipt; and payment. Different procedures apply depending on the value of the goods, services and works to be procured.

1.3 SPC's Request for Proposal (RFP) Process

At SPC, procurement valued at more than EUR 45,000 must be advertised through a Request for Proposal (RFP) with any bids received evaluated by SPC's Procurement Committee to determine the offer that provides the best value for money.

This RFP sets out SPC's requirements and it asks you, as a bidder, to respond in writing in a prescribed format with pricing and other required information. The RFP contains detailed instructions and templates to enable you to submit a compliant bid. It sets out the overall timetable; it confirms the evaluation criteria that SPC will use to evaluate proposals; it explains the administrative arrangements for the receipt of the bids; and it sets out how bidders can request further information.

Your participation confirms your acceptance of SPC's conditions of participation in the RFP process.

Part 2: INSTRUCTIONS TO BIDDERS

2.1 Background

SPC invites you to submit a bid to deliver the services as specified in Part 3.

SPC has advertised this RFP on its website and may send it directly to potential vendors. The same specifications, submission and other solicitation requirements will be provided to all vendors.

SPC has compiled these instructions to guide prospective bidders and to ensure that all bidders are given equal and fair consideration.

Please read the instructions carefully before submitting your bid. For your bid to be considered, you must provide all the prescribed information by the closing date and in the format specified.

2.2 Submission instructions

Your submission must be clear, concise and complete and should only include information that is necessary to respond effectively to this RFP. Please note that you may be marked down or excluded from the procurement exercise if your submission contains any ambiguities or lacks clarity.

Your proposal must include the following documents (annexes of Part 5 of the RFP):

- a) Bidder's Letter of Application (Annex 1);
- b) Conflict of Interest Declaration (Annex 2);
- c) Information about the bidder and Due diligence (Annex 3);
- d) Technical proposal submission form (Annex4);
- e) Financial proposal submission form (Annex 5).

Your proposal must be submitted in two separate emails.

You must submit your **Technical proposal** (Annexes 1 to 4 and all their supporting documents) in English as an attachment to one email. No financial information may appear in the technical proposal.

You must submit your **Financial proposal** (Annex 5) in a separate email. All prices in the proposal must be presented in USD. Your Financial proposal is to be password protected. SPC will request the password in the event that it is required.

Both emails are to be sent to procurement@spc.int with the subject line of your email as: Submission RFP22-4240-PRO.

Your proposal must be received no later than **1/11/2022** by **4PM Fiji Time**. Only one bid per bidder is permitted.

SPC will send a formal acknowledgement to each proposal received before the deadline.

SPC reserves the right to exclude from consideration any proposal not received by the deadline, with incomplete information or in incorrect form.

2.3 Clarifications

You may submit questions or seek clarifications on any issue relating to this RFP. The questions are to be submitted in writing to procurement@spc.int with the subject line: Clarification RFP22-4240-PRO. The deadline for submission of clarifications is 23/10/2022 by 4PM Fiji Time.

Details will be kept of any communications between SPC and bidders. This assists SPC to ensure transparency

of the procurement process. While SPC prefers written communication in the RFP process, at any point where there is phone call or other conversation, SPC will keep a record or a file note of the exchange with prospective bidders.

2.4 Evaluation

Validity

Each proposal will be assessed for compliance with the submission requirements by the Bids Opening Committee. At this stage, basic due diligence will also be undertaken.

To assist in the examination, evaluation and comparison of proposals, SPC may ask the bidder for clarification of its proposal or additional information. The request for clarification will be in writing.

Technical

All valid proposals will be assessed against the technical evaluation criteria set out in Part 4. The criteria are provided with weighted scores according to the relative importance of each. SPC will not change the evaluation criteria set out in the RFP at any stage of the procurement process. Any changes in the evaluation criteria will result in the RFP process being re-issued.

Bidders are expected to familiarise themselves with local conditions and take these into account in preparing their proposal. Where minimum qualifications are set as specific evaluation criteria (which may include educational qualification, professional accreditation or certification, licensing, experience and expertise), proposals submitted must necessarily meet these criteria.

Financial

Any bids that pass the minimum technical evaluation requirements will pass onto financial evaluation.

During the financial evaluation, if there is a discrepancy between the unit price and the total price, the lower price shall prevail. If there is a discrepancy between words and figures the amount in words will prevail.

The total cost of the proposal must be submitted inclusive of taxes in accordance with the applicable legislation, and is not subject to revision.

2.5 Contract award

SPC may award the contract once the Procurement Committee has determined that a bidder has met the prescribed requirements and the bidder's proposal has been determined to be the most responsive to the RFP documents, provide the best value for money and best serve the interests of SPC.

SPC's <u>General Terms and Conditions of Contract</u> will apply to any contracts awarded under this RFP, unless otherwise agreed. Any requested changes to the General Terms and Conditions of Contract must be foreshadowed in the submission.

The award of the contract will be made by contract signed and dated by both parties.

2.7 Legal and compliance

Child and vulnerable adult protection: SPC is committed to the well-being of children and vulnerable adults. All SPC contractors are required to commit to the principles of SPC's Child and Vulnerable Adult Protection Policy (XI.G Manual of Staff Policies). Breach of this requirement can result in SPC terminating any contract with a successful bidder. Any allegations of potential misconduct in relation to this RFP involving children or vulnerable adults should sent to complaints@spc.int.

Confidentiality: Unless otherwise agreed by SPC in advance or where the contents of the RFP are already in the public domain when **shared** with the bidder, bidders shall at all times treat the contents of the RFP and any related documents as confidential. SPC will also treat the information it receives from the bidders as confidential.

Conflict of interest: Bidders must take all necessary measures to prevent any situation of conflict of interest. You must notify SPC in writing as soon as possible of any situation that could constitute a conflict of interest during the RFP process. If you have any familial connection with SPC staff, this must be declared, and approval will then be sought for you to engage in the RFP process. Breach of this requirement can result in the exclusion of the bidder from the RFP process or in SPC terminating any contract with a successful bidder.

Cost of preparation of proposals: Under no circumstances will SPC be liable for any proposal submission costs, expenditure, work or effort that you may incur in relation to your provision of a proposal (including if the procurement process is terminated or amended by SPC).

Currency, validity, duties, taxes: Unless specifically otherwise requested, all proposals should be in USD and must be net of any direct or indirect taxes and duties and shall remain valid for 120 days from the closing date. The successful bidder is bound by their proposal for a further 60 days following notification they are the preferred bidder so that the contract may be awarded. No price variation due to escalation, inflation, fluctuation in exchange rates, or any other market factors shall be accepted at any time during this period.

Eligibility: Bidders are required to disclose to SPC whether they are subject to any sanction or temporary suspension imposed by any international organisation, or whether they are subject to bankruptcy proceedings. You may not be bankrupt or suspended, debarred, or otherwise identified as ineligible by any international organisation. Failure to disclose such information may result in debarment and termination of any contract issued to the bidder by SPC.

Fraud and corruption: SPC has zero tolerance for fraud and corruption. All contractors have an obligation to report potential fraud and corruption. Breach of this requirement can result in the exclusion of the bidder from the RFP process or in SPC terminating any contract with a successful bidder. Allegations of potential misconduct by an SPC staff member or contractor involving fraud or corruption can be sent to complaints@spc.int.

Good faith: The information in this RFP is provided by SPC in good faith. No representation, warranty, assurance or undertaking (express or implied) is or will be made, and no responsibility or liability will be accepted by SPC in relation to the adequacy, accuracy, completeness or reasonableness of this RFP or any information provided by SPC in relation to this RFP.

Modifications: Any clarifications, corrections or modifications will be published on the SPC website prior to deadline. In the event a bidder has submitted a bid before the clarification, correction or modification, the bidder will be informed and may modify the bid. The modified bid will still need to be received before the deadline.

No offer of contract or invitation to contract: This RFP is not an offer to contract or an invitation by SPC to enter into a contract with you.

Privacy: The bidder is to comply with the requirements of applicable legislation and regulatory requirements in force for the use of personal data that is disclosed for the purposes of this RFP. SPC will handle any personal information it receives under the RFP in line with its Privacy Policy, and the <a href="Guidelines for handling personal information of bidders and grantees.

Right to amend, seek clarity, withdraw, not award: SPC reserves the right to: (1) amend, add to or withdraw all or any part of this RFP at any time, or to re-invite bids on the same or any alternative basis; (2) seek clarification or documents in respect of any bidder's submission; (3) choose not to award a contract as a result of this RFP; (4) make whatever changes it sees fit to the timetable, structure or content of the procurement process, depending on approvals processes or for any other reason. Please note that while SPC will not change the evaluation criteria set out in the RFP without the RFP process being re-issued, SPC does reserve the right at the time of award of contract to vary the quantity of services and goods specified in the RFP and to accept or reject any proposal at any time prior to award of the contract without incurring any liability to the affected bidder or any obligation to inform the affected bidder/s of the grounds for SPC's action.

Right to disqualify: SPC reserves the right to disqualify: (1) any bidder that does not submit a proposal in accordance with the instructions in this RFP; (2) any bidder that misrepresents information to SPC; (3) any bidder that directly or indirectly canvasses any SPC employee concerning the award of a contract.

Use of material: Bidders shall not use the contents of the RFP or any related material for any purpose other than for the purpose of considering submitting, or submitting, a bid to SPC.

Warranty, representation, assurance, undertaking: The bidder acknowledges and agrees that no person has any authority to give any warranty, representation, assurance or undertaking on behalf of SPC in connection with any contract which may (or may not) follow on from this RFP process.

2.8 Complaints process

Bidders that consider they were not treated fairly during any SPC procurement process may lodge a protest. The protest should be addressed to complaints@spc.int. The bidder must provide the following information: (1) full contact details; (2) details of the relevant procurement; (3) reasons for the protest, including how the alleged behaviour negatively impacted the bidder; (4) copies of any documents supporting grounds for protest; (5) the relief that is sought.

Part 3: Terms of Reference

Consultancy to Support Pacific Community (SPC) in Enhancement of Digital Earth Pacific (DEP) Computing Ecosystem

A. Background/context

During the 2019 Group on Earth Observation (GEO) week in Canberra, the Pacific Community (SPC) announced a national and regional led consultation process to engage Pacific Island Countries and Territories (PICTs) and develop an Earth and Marine Observation (EMO) action plan based on future needs of EMO in the Pacific. This initiative builds on EMO consultations for the Pacific held in Brisbane in 2018, and a subsequent Pacific Regional EMO Coordination meeting held in Suva in 2019.

Since these initial efforts, a needs assessment¹ was completed in 2021 and a computing environment and prototype data explorer² based on a fork of the Microsoft Planetary Computer has been initiated, forming the foundation for the Digital Earth Pacific (DEP) initiative. Several notebooks for minimum viable products have been developed, based on the needs assessment.

SPC is building DEP³ to be a regional public good, making analysis-ready satellite data freely available and openly accessible for sustainable development in Pacific island countries. DEP will be the fundamental digital infrastructure that will ensure every nation in the Pacific has access to tools and technologies to better understand the changes to Pacific environments and people. DEP will condense years of freely available satellite data sets to provide real-time understanding on development issues. However, DEP is still in its initial phase and the development of the platform is still ongoing and requires further work and refinement⁴.

These terms of reference (ToR) set out the requirements for a consultancy to enhance the DEP platform, implement required backend features, up-scale it's analytical capabilities, and to support SPC as the DEP initiative matures and becomes more responsive to SPC member country needs and user requests.

B. Purpose, objectives, scope of services

With the Microsoft Planetary Computer as the backbone of DEP, the continued development is broadly envisaged as follows:

- Increasing data availability and enhancing analytical capabilities both those available through the PC data catalogue, but also derived products according to prioritised use cases.
- Improve user experience ensure that users can provide feedback on the experience and refine functionality accordingly.
- Create analytic visualisations Develop functionality that allows users, at all levels, to better
 understand the underlying insights gained through the use of EMO data. By selecting a particular
 use case, create a graphical representation that is intuitive and dynamically communicates patterns,
 change, statistics, or trends in an easily consumable manner.

Main elements

The Digital Earth Pacific platform consists of three main elements:

- Compute a compute environment that allows people in the DEP community to run their own analysis on top of the Data Catalog
- Data Explorer a data viewer that allows people to search and discover the core datasets in the Data Catalog and the derived products created in the Compute environment that were made public.
- Data data includes both access to Microsoft hosted and managed data from Planetary Computer and DEP produced data stored in Azure storage accounts.

Platform architecture

In terms of the platform architecture, the DEP environment is deployed as a variant of https://github.com/Microsoft/planetary-computer-hub which runs the Microsoft Planetary Computer. This repository utilizes Terraform and Helm to deploy the environment.

Compute is offered by utilizing Azure Kubernetes service. Deployments are completed using Helm and Terraform. The base environment is available for now 4 cores, 32 GiB of memory. Pangeo Notebook environment. This environment includes Dask as a means of parallel computing over multi-dimensional arrays in Python, with an on demand cluster of worker nodes. Additional compute types were disabled until testing and appropriate cost protections can be instituted.

Data is stored in Azure File Storage for user and DEP common shared data, and Azure Blob Storage for output data. Common data can be accessed directly in the compute environment via a mounted folder in each user's instance. Output storage is accessible using generated limited-lifetime SAS Tokens. We recommend a permanent read-only token for data sharing, and for now as needed write access tokens for publishing data to the output storage.

The Tiler instance uses Development Seed's TiTiler to provide COG and mosaic tiling. The Tiler is deployed into the Azure Kubernetes Service environment using Helm. Currently the Tiler works with any Cloud Optimized Geotiffs or MosaicJson in the output storage container.

The Data Explorer is hosted using Azure Static Websites on an Azure Storage Account. It is automatically deployed with Github actions based on code merges to the develop branch of the repository.

There are 3 core git repositories related to this project, available on request:

- Notebooks This repository has work-in-progress code which demonstrates in progress analysis
 work as well as contains examples documenting additional features not already documented in the
 official PC documentation.
- Compute This repository contains the infrastructure as code required to deploy and update the
 entire compute system into the SPC managed Azure subscription. It is based on the PC example for
 creating a custom PC Hub.

• Explore - This repository contains the code to deploy and update the Data Viewer. It is forked from the PC open source code and modified to specifically deploy just the Explore component with DEP customizations.

Core Requirements and Support

- 1. Strengthen and upscale DEP Analytical Capabilities and Computing Resources under Kubernetes Environment under Microsoft Azure Cloud Infrastructure.
- 2. Enable large-scale machine learning pipelines and ensure availability of requisite cloud processing resources.
- 3. Enhance product visualisation platform https://explore.digitalearthpacific.org for all DEP outputs; data description pages, custom legends and styling, vector layers and time-series support, more flexible multi-product display, charting and analytical display capabilities.
- 4. Support SPC in creating the Pacific Earth Observation (EO) STAC* Catalogue for ingestion into and analysis within DEP Hub, primarily consisting of institutional data, models and legacy products.
- 5. Capacity building and on-going support for internal SPC IT on comprehensive management and troubleshooting of DEP Kubernetes and Azure resources.
- 6. Advisory and technical support for machine-learning pipelines and methodologies eg: label-maker.
- 7. Advisory support for statistical modelling methodologies within the DEP environment eg: metamodelling of building/infrastructure data.

Requested Features

Below is an outline of the near- to medium-term features that require implementation. This is not an exhaustive list of features and is likely to change over the coming months and into 2023 and beyond as the project develops and requirements change. However, for now it is anticipated that the plan is as follows:

- Redeployment of DEP MSPC Hub and Explorer to incorporate changes in MSPC Platform and API
- 2. Enhancements to Explorer
 - a. additional band comparison
 - b. multi product comparison
 - c. data description tooltips, popups, and pages
 - d. general data overview pages, i.e. data catalogue
 - e. legends/style popup
- 3. Creation of DEP hosted STAC catalog to allow for more automated addition of data to Explorer
 - a. Development of tools for publishing from notebooks to STAC catalog
 - b. Deployment of STAC Catalog, Database, API
- 4. Support for DEP analysis e.g. implementation of Pyfes, creation of Pytorch nodes
 - a. Resources to support the development of additional use cases (Python notebook development)
 - i. Pyfes
 - ii. Pytorch
 - iii. Specific data pipeline (TBD)
 - b. Support Development of dashboard application based a derived data and specific use case.
 - c. Support ML and statistical modelling pipelines within DEP environment
- 5. Add ability to display time-series vector layers from Titiler to Explorer (important for coastline change, building extraction etc display)
 - a. Layer overlaying feature for Explorer
 - b. Solutions for when multiple layers are needed in 'compare' mode

6. Method for cataloguing vector layers added to Task 3Support the SPC DEP team in managing and enhancing DEP MSPC Hub, and up-skilling internal SPC IT capacity in Kubernetes

Priorities

The current stage of development requires the following features to be implemented as a matter of priority:

- Redeployment of MSPC DEP Hub and Explorer inline with recent MSPC Platform and API Changes
- Add PyTorch Node Type
- Enable flexible resource allocation for the JupyterLab computing nodes (eg: additional RAM/vCPU Configurations)
- Enable time-series vector layer support in DEP
- Deploy STAC catalogue
- STAC data ingest pipeline
- Add Pyfes and other native libraries to compute environment (within the MSPC container)

C. Timelines

Most of the work is expected to be over a duration of 12 weeks from approximately September to November. The final delivery and final payment will have to be completed by December.

D. Reporting and contracting arrangements

- The contract and final work-delivery approval processes will be managed by the Deputy Director, Oceans and Maritime Programme, Geoscience, Energy and Maritime (GEM) Division.
- Focal point for technical work-delivery will be the Geoinformatics Team Leader, GEM Division.
- It is anticipated that successful vendor will work remotely and weekly meetings will be scheduled with the DEP technical team within GEM to monitor, guide and provide feedback on the developments within an agile project management environment.

E. Skills and qualifications

Wide-ranging expertise in implementing large-scale cloud-native open-source geospatial solutions, with at least 10 years of experience.

Proven experience in guiding the strategy and development of open data and analytical pipelines for highend geospatial applications for decision-making within a developmental context.

Understanding of the challenges of using earth observation data within Pacific Island Countries and SIDS.

Highly values innovation, transparency, and the potential impact open data can have on improving livelihoods and enabling sustainable management of natural resources.

Expertise in working with the Microsoft Planetary Computer platform and the Python open source computing environment

F. Scope of Bid Price and Schedule of Payments

> The rates quoted by the supplier should represent for best value for money.

- > The rate quoted should be valid and are to remain fixed for a period of one (1) year from the date of award of contract, and must be inclusive of, insurance, charges, GST, levies and taxes.
- ➤ If there is a change in the Price for reasons beyond the supplier's control, SPC should be advised promptly and upon approval by SPC, the contract rate shall be amended.

Part 4: PROPOSAL EVALUATION MATRIX

4.1 Evaluation criteria & Score Weight

A two-stage procedure will be utilised to evaluate the proposals, with evaluation of the **Technical proposal** being completed prior to any **Financial proposal** being opened and compared.

The competencies which will be evaluated are detailed in Part 3.

The evaluation matrix bellow also reflects the obtainable score specified for each evaluation criterion (technical requirement) which indicates the relative significance or weight of the items in the overall evaluation process.

The technical component, which has a total possible value of 700 points, will be evaluated using the following criteria.

4.2 Financial evaluation

Financial Proposal score = (Lowest Price / Price under consideration) x 300

INSTRUCTIONS TO BIDDERS

What is a conflict of interest?
